kayaking and mountain biking. "As an avid outdoors person, my view of water is that you don't know a river until you've spent hours standing in it trying to tease a salmon to take a dry fly. You come to appreciate water after feeling the stream beneath your feet."

"Although the forest sector is not a major water user in Alberta it is critical to minimize our impact on water quality and quantity," Keith explains that "Rigorous forest planning processes and the environmental performance of the mills is a testament to our dedication to good water management."

Emerald Awards Are Open For Nominations

Each year the Alberta Emerald Award Foundation's Board of Directors selects a topic of current importance to Alberta's environment. The topic provides many challenges and requires inspirational and environmental leadership.

During Keith's years with the Council, he has been involved with several teams including those working on wetland policy and water allocation. His experience with the consensus decision-making process has been a learning curve; "I'm generally pretty impatient and just want to make the decision and get on with the project, but do recognize that if we can get everyone moving forward together, we can accomplish a lot more than if we constantly rehash issues. Consensus decision making does work but we need to remember that ultimately a decision has to be made."

The 2013 Emerald Challenge Award will recognize excellence and leadership in activities related to **water**. Individuals, groups, businesses and governments are encouraged to nominate water-related projects that demonstrate a significant ongoing commitment to the environment and exceeds normal practices or statutory duties. When Keith is recruiting industry representatives for Council teams, he considers their knowledge of the subject and ability to compromise and seek innovative solutions. "We always discuss the consensus process and the process of investigating alternate pathways to reach a reasonable solution." The sector experienced some challenging years in the early 1990s when it was involved in the Northern Rivers Basin Study but the industry has been exceptionally responsive to environmental issues. Keith adds that "It's a pleasure to work with a group of professionals who truly have a passion for the environment and consider their impacts on a daily basis."

Keith notes that bringing the various sectors together and maintaining the relationships over the years is one of the Council's most significant accomplishments. It takes a lot of work on everybody's part but Alberta is quite unique in its ability to support two great consensus-based organizations like the Alberta Water Council and the Clean Air Strategic Alliance; "I don't think it could happen anywhere else in Canada."

Water CEP Team Nearing Completion

The last two sector CEP plans were presented to Council in June. Since then the CEP team has been busy gathering feedback on its draft report from sectors and Member organizations. The team has reached consensus on two recommendations and is working to finalize its report.



Looking back on this team's work, the irrigation sector, working through the Alberta Irrigation Projects Association (AIPA), presented the first CEP plan to Council in 2010. This sector continues to make substantial progress related to CEP. Richard Phillips, Manager of the Bow River Irrigation District (BRID), will be speaking on "Irrigation's Conservation, Efficiency, Productivity Plan: How far have we

come?" at the AIPA 2012 conference in November. This will be an update, not the official report for all districts, but will demonstrate progress made in the BRID. More information on this presentation and the conference can be found on the AIPA website at <http://aipa.ser2.us/>.

Riparian Team Continues Analyzing Consultant Research



The consultant engaged by this team completed work in June on the report *Current state of riparian lands in Alberta, and the management and stewardship "best practices" (policy, practices and procedures) in Alberta and other jurisdictions*. Team members circulated the final version to their sectors for input and then began discussions on the final report and recommendations. The consultant did a

very thorough job evaluating the state of knowledge on both the extent and health of riparian land in Alberta, which is informing the team's work.

The team continues to work on a definition for Riparian Lands for the final report. The team expects to distribute a package for sector engagement during the winter or early spring.

Fourth WFL Implementation Review Wraps Up

One of the Council's most important tasks is to regularly review the *Water for Life* strategy's implementation progress. In undertaking this review, the WFL Implementation Review Committee followed AWC's approved "How-To" Guide. This included interviewing Government of Alberta (GOA) staff to determine the status of each WFL goal or key direction and the state of completion of each associated actions. The Committee also circulated a survey to AWC sector stakeholders and Alberta watershed stewardship groups via the Land Stewardship Centre of Canada to get their input. The Committee then compiled and analyzed the results, which formed the basis for its recommendations.



The review was done in a spirit of adaptive management, where the regular evaluation of progress serves to highlight strengths,



identify weaknesses and recommend areas where additional focus would allow the strategy to advance more effectively. The review is completed at a strategic level, focusing on emerging water issues and concerns in the province and the effectiveness of the *Water for Life* strategy in

meeting them. This assessment provides a snapshot of the strategy's status, effectiveness and progress as of December 31, 2011.

The team presented its work to Council at the October Board meeting and the report will be posted to the Council's website at www.awchome.ca shortly. Way to go WFL Implementation Review Committee team members!
